## Preface

This Guidebook will provide a roadmap for reconstructing the republican form of government that America was originally founded upon. It is an initiative of The American Government's Resurgence Project developed by the Peacekeeping Task Force for The United States of America, Unincorporated.

If you have not been notified yet, stand hereby noticed that America's de jure government which was established in 1776 was usurped in 1861 but was restored in 1998 and the States of the Union have been called into general session as of 2019 by the Hereditary Head of State for The United States of America, Unincorporated, James Clinton Belcher. The States of the Union have been in ongoing session ever since due to the massive job that is set before us --- which is to transition America out from under the de facto governance of corporate government service providers back into the control of the sovereign people and reconstruct our de jure government.

This Guidebook is designed to be a resource to American state nationals who are wanting to re-establish the de jure government of our nation in every town, in every county and in every state. Our purpose in drafting this guidebook is to assist you in accomplishing this systematically, competently and peacefully.

Since actual American history has been deliberately erased and our de jure government usurped by the Corporations that run the world today, a committee of American state nationals volunteered to compile the most accurate research we could find on how our de jure government operated, what mechanisms were used to persuade us to relinquish our freedom to the corporatocracy, and what we need to do to bring the principles of self-determination and self-governance back into our local communities.

The information in this Guidebook will show you the how and the what that needs to be done exactly. The foundational principles contained herein and the bulk of this content are based on the extensive research of historian and Fiduciary for the Federation of States, Anna Maria Riezinger and the Federation's Living Law Firm. Additional perspectives and analyses were garnered from various research venues by the Committee to make this information actionable and complete so when it is implemented the end result may produce a true replica of what freedom looks like for us living people.

The Committee decided to present this information in digestible sections that starts you off with the foundational education you will need to learn first in order to take on the task of assembling a proper and competent government. Each section begins with Key Points and ends with Take Away Questions to enhance your learning experience. The final sections cover the grass roots actions required for the local townspeople to regain complete control of your local economy and local laws. A source list is provided with each section for you to review the materials and evaluate the interpretations that the Committee inputted into this content.

## Introduction: State of Emergency

Brace yourself for what we are about to disclose to you within the 8 Sections of this Guidebook.

Allow us to get straight to the point.

The reason that you are experiencing the government overreach from our federal United States government and its State government subsidiaries is because our American government has not been in operation for over a century.

The reality is that we have a de facto government running this country in the absence of our de jure government.

Let us define these two terms for you.

De facto refers to what exists in practice or reality, while de jure refers to what is established by law. A de facto leader, for instance, exercises authority without legal right, whereas a de jure leader possesses the legal right to rule, regardless of their actual power.

More precisely, a "de facto government" is one that seizes or retains power through means not outlined in the country's organic constitution, like a coup.

That is the unfortunate situation we have in America today and in the world for that matter.

Our States and Counties have been under military occupation since 1861 by the British Territorial U.S. Military serving as a foreign-paid, mercenary force. Our national identities as native-born Americans have been stripped away from us since 1868. All of our County and State public land resources have been purloined by our U.S. Congress and claimed and collateralized as the property of a Municipal United States corporation since 1871. Our United States Treasury has been transferred to the International Monetary Fund since 1924. All of our lawful money, our gold and our silver, has been confiscated by a private commercial banking monopoly since 1933. Every County and State elected government official has been working for the United Nations corporation since 1976. All of this places **every town in America under a State of Emergency**.

America has been in this State of Emergency for 165 years. Every year that goes by, we are losing more and more of our sovereignty as American people. Many have taken calculated actions to stop this but with limited success. We need every American to accept the responsibility for this and stop it once and for all.

To end the illegal mercenary-military occupation requires that our de jure government provides America and the world with a **competent civilian alternative**. Although this task will be daunting, it nonetheless, must be undertaken on a systemic level if we are to correct this grave error completely.

In 2017, our restored de jure Federation of States, The United States of America, Unincorporated, chartered an organization called the Peacekeeping Task Force (PKTF) to facilitate a peaceful transition of our communities out of this State of Emergency toward the restoration of a national civilian government occupation.

The PKTF is providing this Guidebook to assist Americans in taking the necessary action to reinstall our lawfully elected public officials and our sovereign Assembly governments at the town, county and state levels.

We need you to recognize that our federal United States government has substituted itself for our American government without your knowledge. In order to prevent undue and unwanted civil unrest, they can only retreat back into their proper jurisdiction when we, the American people, take our proper place as the de jure government in every town in this country.

You are not expected to know what a “de jure” government is, let alone, what is meant by a “republican form of government.” You are not expected to know that the federal United States and The United States are both instrumentalities within our American government’s structure and yet not the same entity. So, in order for you to take on this duty as the ultimate Creators of government, you will need to start with studying the Reconstruction Roadmap of the American Government laid out for you on the following pages.

#### National Identity Crisis

This **Reconstruction Roadmap of the American Government** presents a visual guide that lays out the path required to restore the lawful de jure government of America that has been missing for more than 160 years. Each of us needs to declare our birthright political status, acknowledge the respective jurisdictions, and operate within the appropriate government form. By doing this, Americans regain their rightful control over the governance of this country.

The paramount principle of our **republican form of government** is to honor and protect the rights, prerogatives and assets of the individual.

### ~ 2 Routes for Action ~

3,143 Counties are comprised of 19,500 plus Towns. Townspeople have the right and responsibility to gather in Assembly – not in a council, not as a commission and not as a trustee. As Fiduciary Deputies, we self-govern and we provide ourselves with a republican form of government, i.e. **The Clark County Assembly** – Land and Soil Jurisdiction.

#### route 1

Self-governance

Populate every county with 2 declared ASNs to reclaim its American provenance as The Union State, i.e. **The Nevada Union State**, a republican state.

"This is the **one, urgent, whole, entire, gotta do it thing.**"

#### route 2

Diplomacy

Hereditary Head of State  
Federation of States

Each of the 50 States of the Union, i.e. **Nevada**, had to be repopulated starting with just one (1) declared ASN.

Then the Hereditary Head of State called all 50 States to assemble in general session, i.e. **The Nevada Assembly** - Land, Sea, and Global Air Jurisdictions.

**A Declaration of Joint Sovereignty & Sovereign Letters Patent** were reissued and served to the United Nations.

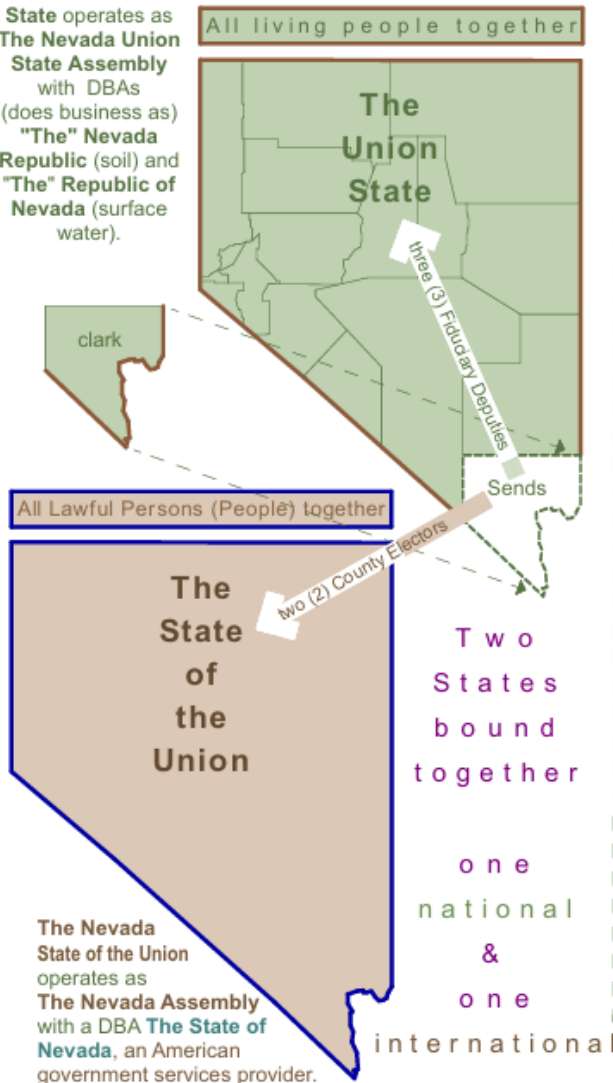


## Reconstruction Roadmap of the American Government
